We will publish indices for each jurisdiction, detailing (i) the average number of pro bono hours performed by locally-based lawyers at each participating firm and (ii) what proportion of the lawyers have performed 10 hours or more of pro bono. We will also group such data to generate regional figures. No other data will be published in an attributable form.

Please note that if the pro bono work done by paralegals or summer associates is included in your firm's total pro bono hours, such employees must also be included in the firm's headcount.

Please provide separate data for each country in which your firm has an office. If your firm has more than one office in a country, please aggregate the information to provide a country-wide figure. Unless otherwise specified, please provide data based on the most recent calendar year, or such other 12 month period you prefer to choose. Please ensure that the same 12 month cycle is used for any subsequent submissions of the TrustLaw Index of Pro Bono so that year on year comparisons can be developed. Please indicate what 12 month period your submission relates to.

 - Qualifying Fee-Earners Who Recorded 10 Hours of Pro Bono Time: please indicate the number of Qualifying Fee-Earners who recorded at least 10 hours of pro bono time on Qualifying Pro Bono matters over the chosen 12 month period. Please note this information

will be published as a percentage and not as an unadjusted total figure provided. If, due to changes in staffing levels, this figure is higher than the Headcount as at 31 December, please just use the higher figure. Please provide a separate figure for each jurisdiction in which you operate.

- Qualifying Fee-Earners Who Recorded Any Pro Bono Time: please indicate the number of Qualifying Fee-Earners who recorded any time on Qualifying Pro Bono matters over the chosen 12 month period. Please note this information will not be published, but will rather be used to inform our industry analysis and will only be discussed on an anonymised or aggregated basis. Please note: information and data relating to your pro bono practice will be used to feed into our sectoral analysis and will only be published in aggregated form. Where we have requested data about partner engagement in pro bono programmes, such data will also not be accredited to individual firms but will rather be used to inform our industry analysis in an anonymised or aggregated manner.
